INFORMATION NEEDED BY PNM FROM THE SUBSCRIBER ORGANIZATION
COMMUNITY SOLAR SUBSCRIBER ORGANIZATION MONTHLY SUBSCRIPTION
PRE-VALIDATION AND ENERGY APPLICATION REQUEST DATA FILE

The information below must be received by the utility from the subscriber organization in the identified field format.

By the 24th calendar day of each month, a data file containing all data marked with an asterisk shall be transmitted to the utility for pre-validation.

A finalized data file with all fields completed shall be transmitted to the utility one business day before PNM's annual meter reading schedule cycle 13 date.

All data shall be exchanged with SSH File Transfer Protocol ("SFTP") via plain text files in comma separated value ("CSV") format. Microsoft Excel can generate and read CSV files.
